

Families Can Contribute to Efficiency in Care for the Aging

- In 2009, caregiving provided by family or friends in the United States was valued at an estimated \$450 billion—more than the \$360 billion spent by state and federal governments on health and aging care services for low-income people.
- In 2002, the services provided by family caregivers in Canada was estimated to be equivalent to 276,000 full-time employees.



The Family Impact Discussion Starters

How will the policy, program, or practice:

- 1) Support rather than substitute for family members' responsibilities to one another?
- 2) Reinforce family members' commitment to each other and to the stability of the family unit?
- 3) Recognize the power and persistence of family ties, and promote healthy couple, marital, and parental relationships?
- 4) Affect families that vary in race-ethnicity, socioeconomic status, geographic regions, and so forth
- 5) Engage and work in partnership with families?



3) How Can Family Impact Analysis Be Used to Bring a Family Impact Lens to Agencies and Organizations?

Qualitative Family Impact Analysis of Child Care Centers


- Sample included two child care centers serving 112 and 304 children in towns with populations of 10,000 and 15,000;
- Focus groups were conducted of 8 to 12 participants, separately for parents and staff about how the center does and does not support families;
- Center directors completed a survey on family demographics and a checklist on center operating policies and procedures.

Changes in Center Policies and Practices

- The Director credited the family impact analysis with a congregation vote to remodel the church basement into a more usable, multi-purpose space;
- Remodeling allowed private space for staff to meet with parents to discuss their child's development;
- Remodeling allowed the opportunity for a summer camp program requested by parents;
- A new policy required the same staff person who greeted the parent when the child was dropped off to meet with them at pick-up;
- Breakfast times were adjusted so all children could eat;
- One center began monthly surveys to solicit parent feedback.

What Contribute to the Effectiveness of the Family Impact Lens

- 1) The family impact lens is effective because it is nonpartisan—conducted without a pre-existing position or partisan agenda.
- 2) Family impact analysis does not recommend that specific actions be taken.
- 3) Instead, the results raise considerations that policymakers can factor into their policy decisions.

What Organizations are Well Situated to Provide Nonpartisan Leadership?

The leadership varies from country to country.

- In the United States, leadership is provided by universities, by Extension Services, and by nonpartisan, nonprofit organizations.
- In other countries, leadership comes from nonpartisan institutes, centers, or government agencies.
- Belgium has a NGO that is apolitical and independent with a membership of 310,000 families.
- The European Union established the Seventh Framework Programme which involves 25 universities and 3 NGOs.

FAMILIES

Families are a cornerstone of a sound economy and a strong society. Families financially support their members, and care for those who cannot always care for themselves—the elderly, frail, ill, and those with disabilities. Yet families can be harmed by stressful conditions—balancing work and family responsibilities, preventing youth substance use, caring for aging relatives, and earning enough money to avoid poverty. Public policy can help families deal with stressful conditions and is often more effective than focusing on individuals. Keeping the family foundation strong today pays off tomorrow.

Families are a cornerstone for raising responsible children who become caring, committed contributors in a strong society, and competent workers in a sound economy.
